

**Informal History of 210 High Street, Newburyport,
Massachusetts**

PREFACE

This history was compiled for the occasion of the 50th birthday of Dr. John McManamy, a current owner of the residence at 210 High Street and the third practicing physician to reside in the house since it was built in 1847. It contains a title history, an anecdotal history resulting from first-hand accounts of people in town and former residents, and a residency record which summarizes information on the curious question of who lived in the house over the years. The history is supplemented by copies of the first deed to the land, the wills of Eleazer Johnson and Daniel Johnson dated 1847, a chain of title and a short genealogy of the members of the Johnson family who built the house. The information obtained within was compiled through research of the grantor index and probate records at the Registry of Deeds, research at the Newburyport Public Library Documents Room and the Old Newbury Historical Society. Please bear in mind that the research was not done by a professional historian, and it may well contain errors of fact or opinion. Anyone who disagrees with the facts or conclusions herein is welcome to write their own history.

I. Title History

Eleazer Johnson (b. 1773) was the fourth generation of Johnsons in the Newburyport area. He acquired the parcel at High and Olive Street from Samuel Newman, for \$200 in April 1836. (See deed attached) His wife was Sally Newman, with whom he had eight children.

Eleazer Johnson's grandparents were Eleazer and Elizabeth (Titcomb) (Toppan) Johnson. Eleazer Senior has been described as a Son of the Revolution. It was he who led the first tea party, the one that happened in Newburyport, prior to the destruction of the tea in Boston Harbor. The tea was seized from a British vessel and burned in Market Square, Newburyport. The adze he used to break open the chests of tea is at the Old Newbury Historical Society. He had black hair and eyes, and is said to have been able to carry timber over the bows of a vessel against any four men in his yard. He inherited one-half of his father's shipping industry and became very influential in the shipping industry in town.

Another family ancestor, Judge John Lowell, built the house diagonally opposite on High Street, #203, in 1771. He was said to be the author of the clause in the State Constitution abolishing slavery.

Eleazer Johnson's father, Joseph, was a ship captain. Not much is reported about him, but Joseph's brother Eleazer played a role in the Revolution. Like his father, he was considered to be strong, evidently a major advantage in the shipbuilding trade. He was declared to be "the strongest man in town". He commanded the brig "Dalton" which was captured by the British in Dec. 1777, and he was imprisoned in Plymouth for two to three years in old Mill Prison. The boat had a crew of 120 men and had sailed in 1776. He was finally released through the efforts of Benjamin Franklin. He later became the President of Mechanics Bank.

Our Eleazer (Joseph)(Eleazer)(William) Johnson (see attached genealogy) was a Newburyport merchant. He was a member of the Newburyport Maritime Society, and like his ancestors, he also had some adventures as a ship captain. His ship was captured by British privateers off the mouth of the Mississippi and a prize crew put aboard. He succeeded in recapturing the vessel "by a stratagem" (Johnson Genealogy). Later in his life he went into business with Paul Simpson, whom he had rescued from drowning in the Merrimac River.

Eleazer Johnson lived in the Lowell-Johnson House at 203 High Street from 1809 until his death on 8/3/1847. Upon his death, he willed to his wife Sarah Johnson ("provided she remains a widow") his dwelling house on High Street, next to the Dexter estate (see will attached). He bequeathed to his daughters, Martha Jane and Nancy G. Johnson, his house in Middle Street, "with the Barn and out Buildings with the land under and adjoining the same". He granted his sons Richard and Daniel his store on Terry Wharfe and some shares in Mechanics Bank. He specified that the remainder of his estate,

including the land which later became 210 High Street, be divided one third to his wife and the remainder to his surviving children and their heirs. This will was signed in May 1844. He died three years later, on 6/7/1847.

His son Daniel Johnson died "on or about 8/18/1847". The will of Daniel Johnson dated 7/14/1847, (see will attached) designated him as a Newburyport gentleman. His will calls for his executor to "*dispose of such part of my estate as may be sufficient to purchase the lot at the corner of High Street and Olive Street, which belongs to the estate of my said father...and to erect upon said lot a two-story dwelling house, with four rooms upon the floor, and an entry through the centre of the house – together with such outbuildings, and all other conveniences as may be necessary and proper – the whole to be finished in the best manner.*" He had the house built for his two sisters, Martha Jane and Nancy G. Johnson, who were unmarried at the time. The will states as a condition of the bequest: "that said property shall not be sold, or mortgaged, or any lien created upon it during the lifetime of either of my said sisters, but shall be enjoyed by them personally whether married or not, and if married, in the same manner as if they were singlewomen". Surprisingly, there is no record of Nancy Johnson in the genealogy or street directories, however, Martha did live in the house for some time (see Residency Records, below.)

On 11/30/1847 Joseph Johnson and William Johnson, merchants, with Richard, mariner granted to Martha Jane and Nancy G. Johnson for \$880 the remainder of the land. Apparently this is a portion of the lot adjoining the house which had remained the property of Daniel's brothers as a result of their father's will. Having no use for the property, they sold it to their sisters so that it might remain with the house.

In January, 1926, William R. Johnson, Martha Jane's nephew and Richard's son, granted to a Marjorie H. Thurlow (unmarried) ½ of the land and buildings bounded by High St., Low St and the Morrill land plus ½ of the land bounded by High Street/Cashman property/Caldwell/Olive Street. This is part of the 210 High Street parcel. Later the same day Marjorie H. Thurlow granted to William R. Johnson and Lillian R. Johnson (husband and wife) the same property. This property flip may have taken place to add Lillian to the title. Two years later, William died at age 73.

Upon William's death, Lillian and Frances R. Johnson, Lawrence B. Johnson and Richard W. Johnson (three of her living children) transferred the property to Charles and Sara Hall. Seven-eighths of the property were transferred for \$3,000. The remaining one-eighth of the land, the southern portion, was transferred by Lawrence B. Johnson, Lillian's son, as guardian of his youngest sister Elizabeth Johnson on 8/2/1928. Elizabeth was 17 at the time. This portion of the property was transferred from him to Charles F.A. Hall and Sara J. Hall for \$1,125.

Charles Hall began to practice osteopathic medicine in Newburyport in 1902. He and Sara lived together in the house until her death in the early 1940s. In May 1946 Charles Hall and Elizabeth Chetty Hall (his second wife) transferred part of the property to Elwood and Barbara Johnson, "*the southern portion, including the garage on the*

remaining land of the grantor. Grantees are permitted to leave it until requested by grantor to remove it." The Halls retained ownership of the northern portion of the property in order to maintain residency in Newburyport for their children to attend school there. The next year they attended school in West Newbury, and the remaining portion of the property was sold from Charles F. A. Hall to Elwood Johnson in 1947. This Johnson family is unrelated to the earlier Johnsons, so far as the author can gather at present.

Elwood Johnson died in 1981, leaving considerable debts including a tax lien. In November 1986 Barbara H. Johnson transferred the property to Manuel J. and Mariana B. Muros. In May 1992, the Muros family transferred the house and land to the McManamy family.

Thus, there have been a total of five families in the house over its 154 years to date: the Johnsons (1847 to 1928), the Halls (1928 to 1946), the second Johnsons (1946 to 1986), the Muros (1986 to 1992), and the McManamys (1992 to present). There have been three practicing medical doctors living in the house, excluding Sara Hall: Charles Hall, an osteopathic physician, Elwood Johnson, a general practitioner, and John McManamy, an anesthesiologist and pediatrician. A number of lives began, ended, and were probably deeply affected by living in the house, and many made their mark on it. The next section is an informal compilation of stories that have come to light concerning the house and the people who lived in it.

II. Anecdotal History

The most detailed history of the house came from a visit by the Hall sisters, Kay (Francis) and Petey (Marion) on May 30, 2001. Kay married Ernest Frey and now lives with him on Prospect Street in West Newbury. They came to the house for a visit and tour, along with Dustie, the sister of John Battis, a former Olive Street neighbor, and another childhood friend. All four women went to Kelley School and had memories of assemblies in the main hall, skating on the Mall, walking to Parkman School each day on foot to make way for the Immaculate Conception students to use Kelley School when their school burned down, and the German dentist during World War II who visited the school and remarked on students' teeth.

They lived in the house in the 1930s and 40s, before the second Johnsons. Their father was an osteopathic physician who was helped through medical school by his first wife, Sara Hall. She herself was also a physician, though she may never have practiced medicine. She died of cancer, which she kept hidden from him until the final few weeks of her illness (per the Hall daughters). In 1946, Dr. Hall married a second time, to Elizabeth Chetty Hall, a woman 33 years his junior.

Dr. Hall used the front of the house for his office: exam room on the right, waiting room on the left, expanding if needed into their living room on the northern side of the house. He may have had a washroom in the connecting room between the front and back of the house on the Olive Street side, since the plumbing and tile work are still there. Their father's portrait hangs in Anna Jacques Hospital, as does their "uncle", Mel Ames, who took over their father's practice upon his retirement. Elwood Johnson's portrait hangs there also.

They remarked on the house and what has changed:

There was a coal-burning stove in the kitchen and pantries on the sink side of the kitchen, another pantry making an entryway at the little side door leading to Olive Street that we now keep bolted shut. This door was their main back door to use.

There was wallpaper with a hunting theme in the downstairs hall, evidence of which still remains in the closet behind the bathroom.

The mantels were all painted, not black marble as today. (The Muros' had stripped all the paint off the mantels.)

They drove in from High St. to a one-car garage.

Their parents slept in the southwestern side and the kids in the southeast side as we do.

Their floor was linoleum. The governess/maid, Jukie, slept in the room over the kitchen, which is now our son Evan's room.

They played dress up in the third floor closet.

Petey seems to be a mischievous sort, with lots of energy even now in her 70s. She spoke of hiding things in the "rat hole" (where is it ?). Among the treasures lost there is a Masonic ring that belonged to a friend of her mother's. She also described playing up in

the unfinished attic which has no floor and falling through the floor into the third floor closet.

They listened in the upstairs hallway while their parents entertained numerous guests, including the Tuesday Club, where the men ate and drank and shared writings with each other (including the author John Marquand). Their father threw a ball to the dog in the formal room and shattered a lampshade, which was afterwards turned towards the wall to hide the spot.

They summered on Middle Street in West Newbury, which they called "The Farm" although it had no animals.

Other recollections about 210 High Street:

When we originally moved in to the house in 1992, the movers knew the house well as "Doc Johnson's office". They remembered that the exam room was on the right as you enter, and the waiting room on the left. As they brought boxes in, they asked us to identify the destination as to their old references. "Where to? Exam room or waiting room?" This was the first of many references to old Doc Johnson that we encountered.

We can always tell if someone comes to the house who has been associated with it in the past, since they always come to the kitchen door. (O'Connor painters, Atkinson Oil). We never use this door, so this necessitates a long process of unbolting and moving items to gain access to the door. One such visitor told us about the son of Doc and Mrs. Johnson. He was quite shy, apparently, and had a rabbit in the yard that he played with. This visitor said that Doc Johnson worked until the day he died, and that Mrs. Johnson had a drinking habit (not surprisingly). She also gave piano lessons in the home.

A number of people seem to have a proprietary sense of the home. Shortly after we moved in, we got a call from Atkinson Oil. They informed us that they intended to service our boiler, as they had done continually since 1938 when it was installed. They have provided very good service.

III. Residency records

The source for these records is the street directories, which began in 1849.

Oddly, there is little consistent residency history at 210 High Street prior to 1929 when Dr. Charles and Sara Hall moved into the house. Prior to that time, there is some history of Johnson family members living at a so-called 202 High Street, and perhaps the street numbers were changed at some point to accommodate new housing built closer to downtown. A review of the residence records suggests that 202 High Street referred to the house that is now listed as 210. Because of this, this author assumes that 202 and 210 are synonymous.

Another curious fact is that the records show a veritable party of Johnson family members residing at 203 High Street, diagonally across the street, and a few members listing their address at 202/210 High Street after having listed it at 203 the previous year. In some periods, there appears to be no one listing 202/210 High Street as his/her address in the street directory. Therefore it appears that perhaps 210 was used as a sort of annex for the Johnson family, with the person's main address remaining at 203 High Street.

Although the house was built around 1847 for the Johnson family, there is no record of any Johnsons residing there until 1854, when William Johnson listed 202 High Street as his residence. He "moved over" from 203 where he had listed his residence since 1849 with Joseph, merchant and Captain Richard (his brothers). William would have been 49 years old at the time, and unmarried. He was joined in 1856 by his sister, Martha Jane, who was then 45 years old, and for whom the house was originally built. (There is no reference to Nancy Johnson in the residency records either, thus her existence continues a mystery though she is named in Daniel Johnson's will as his sister.) In 1869, William and Martha remain at the house and are joined by someone not in the immediate family, a boarder, Harrison G. Johnson, whose address is listed as 210 High Street. This is the first mention in the records of that address.

In 1889, Miss Caroline Johnson, Mrs. Richard Johnson, and William R. Johnson list their residence at 203. Mrs. Richard Johnson is Frances (Woodbury) Johnson, the wife of Captain Richard in the preceding paragraph. William R. would be the 34-year-old son of Captain and Mrs. Richard Johnson, and Caroline would be their 36-year-old daughter. Apparently William R. stayed at 203 when he married Lillian Richardson, though they were the owners of record at 210 at that time. Their children, Lawrence B., Frances, and Richard W. all lived at 203 in 1919, when they were in their 20s and were working as an actuary in Boston, a bookkeeper and a student, respectively.

From 1879, when Harrison G. is the only Johnson resident at 210, to 1929 when the Halls purchased the home from the Johnson family and began residency, there are no Johnsons listing 202/210 as their abode. It is hard to believe that it remained vacant, hence the supposition that there was informal movement back and forth between the two houses.

CHAIN OF TITLE

1. Samuel Newman, for \$200 on 4/1/1836. (B290 leaf 30) grants to Eleazer Johnson (b. 1775) the parcel at High and Olive Street.
2. Eleazer Johnson on 7/6/1847 (will #43649 B414P148) wills parcel one-third to his wife and the remainder to his surviving children and their heirs.
3. Daniel Johnson on 10/5/1847 (will #43643 B414P197 probated 10/5/1847) wills that his executor sell items from his estate sufficient to purchase the lot and build a two-story house on it for the use of his sisters, Martha Jane and Nancy G. Johnson.
4. Joseph Johnson and William Johnson, merchants, with Richard, mariner, on 11/30/1847 (B392Leaf 18) grant to Martha Jane and Nancy G. Johnson for \$880 the remainder of the land.
5. William R. Johnson grants to Marjorie H. Thurlow (unmarried) on 1/22/1926, ½ of the land and buildings bounded by High St., Low St and the Morrill land plus ½ of the land bounded by High Street/Cashman property/Caldwell/Olive Street. This is part of the 210 High Street parcel.
6. Marjorie Thurlow 1/22/1926 (B2669P201) grants to William R. Johnson and Lillian R. Johnson (husband and wife) ½ of land bounded by High/Cashman property/Caldwell/Olive St. This is the same parcel.
7. Lillian R. Johnson, widow, Frances R. Johnson, Lawrence B. Johnson and Richard W. Johnson (her children) grant to Charles and Sara Hall seven-eighths of the property for \$3000 in 1928.
8. Lawrence B. Johnson, guardian of his minor sister Elizabeth Johnson - probate 8/2/1928 grants the remaining one-eighth of the land, the southern portion, to Charles F.A. Hall and Sara J. Hall for \$1125 (B 2775P500, 8/2/1928).
9. Charles Hall and Elizabeth Chetty Hall (his second wife) on 5/27/1946 (B3491P177) grant part of the property to Elwood and Barbara Johnson, "the southern portion, including the garage on the remaining land of the grantor."
10. Charles F. A. Hall grants to Elwood Johnson the remaining northern portion on 5/20/1947 (B3528P90).
11. Barbara H. Johnson grants the property to Manuel J. and Mariana B. Muros for \$265,000 on 11/20/1986 (B8692P582). Tax lien, probate #354575
12. Muros family grants property for \$315,000 to McManamy family on 5/28/1992, (B11312P508).

And I do hereby for myself, my heirs, executors and administrators, covenant and engage to and with the said Eleazer his heirs and assigns, that I am lawfully seized in fee of the premises, that they are free of all incumbrances, that I have good right to sell and convey the same in manner aforesaid, and that I and my heirs will warrant and defend the same to him the said Eleazer Johnson his heirs and assigns, forever, aga-

Genealogy of Portion of Johnson Family Related to 210 High Street

Source and references for this abbreviated genealogy are from The Genealogy of the Descendents of William Johnson (located at Newburyport Public Library reference room and the Old Newbury Historical Society)

1. William Johnson (pg. 23)

The earliest ancestor in the Newburyport area is William Johnson, born 2/21/1679. He was considered very prosperous in the seafaring industry, and went by the appellation "Captain". He had a total of 14 children with several wives. With Martha Pierce, he had a son Eleazer, born 5/11/1718. William Johnson died in 1741.

2. Eleazer Johnson (pg. 60) lived at Federal and Water Street. He married Elizabeth (Titcomb) Toppan in 1741. (Mr. Toppan had died without any children from the marriage with Elizabeth.) Eleazer was considered a "Son of the Revolution" and a ship captain. He was a leader in the stamp and tea tax riots against England. He died intestate on 5/12/1792. His fourth child was Joseph.

3. Joseph Johnson (pg. 115) was born in 1743. He married Elizabeth Dole in 1767 and died 3/5/1775, aged 31, intestate. He was also a ship captain. He and Elizabeth had several children, one of whom was Eleazer Johnson. Another was a boy named Richard who drowned with Captain Willomb and his crew at sea in 1781, aged 12 years (buried along with his father in Section D-6 of Old Hill Burying Ground).

4. Eleazer Johnson (pg. 193) was born 5/9/1773. He married Sally Newman in 1797 and died 6/7/1847. Eleazer and Sally had eight children, of which all but one died without children.

Martha Jane b. 1811. She died unmarried 12/19/1876.

Ann b. 1815

Daniel b. 12/15/1819, died unmarried 8/18/1847. He had the house built for Martha.

5. Richard Johnson (pg. 193) married Frances Woodbury in 1852 and died in 1872. His profession was master mariner. He and Frances had two children, Caroline and William R.

Caroline Johnson was born 1853 and died unmarried in 1926.

6. William R. Johnson (pg. 314) was born in 1855. He married Lillian Richardson and was President of the Newburyport Five Cents Savings Bank. He and Lillian had 5 children. He died in 1928.

Lawrence B. b. 1893, died unmarried in 1940.

Frances b. 1895

Margaret (died young)

Richard b. 1905, WWII.

Elizabeth, b. 1911. Had two children, Lawrence and Frances.

Third - I order and direct the Executor hereafter named to dispose of such part of my estate as may be sufficient to purchase the lot of land at the corner of High Street and Olive Street, in said Newburyport, which belongs to the estate of my said father - and to erect upon said lot a two story dwelling house, with four rooms upon the floor, and an entry through the centre of the house - together with such outbuildings, and all other conveniences as may be necessary and proper - the whole to be finished in the best manner, and at
